Community Based Services Case Management services provide Hennepin County families with children experiencing severe emotional disturbances access to a variety of social services, including mental health, educational, interpersonal, vocational, medical, dental, insurance and recreational services. Case Managers serve children, ages three through 18, advocate on behalf of the children's needs and coordinate care across multiple providers. Approximately 474 children received Case Management services in 2020 and 487 in 2019. (Continued on Schedule O)

4b (Code:) (Expenses \$ 5,832,825. including grants of \$) (Revenue \$ 4,154,151.) Outpatient Individual & Family Therapy The Outpatient Therapy program provides mental health assessment and treatment for a wide range of mental health concerns for children from birth to age 18. Located at clinics in Minneapolis, Brooklyn Park and Minnetonka, the Outpatient Therapy program served approximately 1,643 children in 2020 and 1,601 children in 2019. (Continued on Schedule O)

4c (Code:) (Expenses \$ 1,853,582. including grants of \$) (Revenue \$ 864,149.) Intensive Therapeutic Groups Day Treatment services provide a half-day therapeutic classroom to help young children with severe emotional and/or behavioral challenges gain the skills needed to be successful in their families, at school and in the community. Family therapy and school collaboration with the child's teachers is also provided. Approximately 86 children, ages three to nine, received Day Treatment services in 2020 and 108 in 2019.

The COVID-19 pandemic negatively affected Washburn's 2020 fee for service revenue with 5.67% drop compared to 2019 actual and 13% shortfall compared to the 2020 projected budget revenue. Washburn rapidly and successfully pivoted to provide care via telehealth working with payers and clients so Washburn Center could continue providing transformative children's mental health. During 2020 Washburn Center received a \$2,576,600 forgivable "Payroll Protection Program" loan from the United States Small Business Administration, which was much needed liquidity to help with payroll. In addition, Washburn Center received \$1,188,948 of Coronavirus Aid, Relief, and Economic Security (CARES) Act Provider Relief Funds administered by the department of Health and Human Services (HHS) during the year ended December 31, 2020.

Form 990, Part III, Line 4a, Program Service Accomplishments:

Crisis Stabilization provides intensive in-home therapy, skills building and parent support to increase stability and help children with severe emotional and behavioral difficulties avoid hospitalization or out-of-home placement. Approximately 457 children, ages three to 18, received crisis services in 2020 and 655 in 2019.

Early Childhood Outreach provides observational assessment of children in Hennepin County child care and preschool settings. The program offers consultation and collaboration with teachers and guardians to identify and address social, emotional, behavioral and/or developmental concerns. Training to teachers is available on request. This program

served 27 children, from birth to kindergarten, in 2020 and 66 children in 2019.

Intensive In-Home therapy is available for families whose children, ages five to 17, are at risk of being removed from their homes due to severe emotional and behavioral difficulties. Therapists collaborate with parents in the home setting to improve family functioning and help children develop life skills to increase stability across settings. Approximately 268 children were served in this program in 2020 and 224 in 2019.

Family Focused provides intensive in-home family therapy and a therapeutic preschool to strengthen the parent/child relationship and support the healthy functioning and development of children who are having social, emotional or behavioral difficulties and/or experiencing environmental stressors. This program served approximately 230 children, from birth to kindergarten, in 2020 and 226 children in 2019.

School-based mental health services offer families convenient on-site access to assessment, treatment and school consultation. Washburn Center clinicians are located at several schools in Minneapolis, Eden Prairie and Bloomington public school districts. The age of the clients vary by school. Washburn Center for Children (Washburn Center) is a critical community resource that provides compassionate therapeutic care to families and offers training to professionals who work with children. Founded in 1883, children have come to Washburn Center for help succeeding at home, in school and in the community for 138 years. Washburn Center nurtures every child and family's well-being and full potential through transformative children's mental health care.

Washburn Center is a leading children's mental health center in Minnesota, offering comprehensive care for children with anxiety, depression, loss, grief and trauma. Washburn Center serves more than 3,700 children, birth through age 18, and approximately 11,700 family members through an array of center-based, in-home and school programs. Clients live in the Twin Cities area and its surrounding suburbs, and over 65% of the children come from low-income households. Comprehensive and evidence-based children's mental health services include: assessment, evaluation, individual and family therapy, psychological evaluations, psychiatry and care coordination. Services are designed to develop skills, resolve problems and connect with resources to help children be more successful at home, in school and in the community.

In addition to comprehensive therapeutic services for children and families, the agency offers in-house and online training in best practices in children's mental health care for clinicians, interns and allied professionals to ensure children receive the best quality care. The United Health Foundation Training Institute at Washburn Center for Children, established in 2014, trains thousands of professionals nationally and internationally so that children can receive the best

possible mental health care. Additionally, the agency trains about 50 undergraduate, graduate and post-graduate students annually. Washburn Center's doctoral internship program is accredited by the American Psychological Association.

Impact in the community

A 2015 research report released by the Center for Advanced Studies in Child Welfare (CASCW) at the University of Minnesota shows that Washburn Center "has a significant impact on the well-being of children in Minnesota." CASCW's researchers found that children "benefit greatly from services received at Washburn Center" and their social, emotional and behavioral functioning improved in clinically meaningful ways over the course of treatment. Children's improvements were better than expected after receiving mental health services at Washburn Center, compared to typical progress reported for similar services.

During 2013, Washburn Center established the Washburn Center for Children Holding Company (WHC) to construct and own a new children's behavioral health facility and training center. With support from the CEO, the Director of Operations has primary responsibility for all follow-up and investigations of each reported incident, except if the incident involves the Director of Operations. The board of directors will review any issues reported to them. A journal of reported incidents, follow-up actions taken and resolutions will be kept and reviewed annually by the CEO, Director of Operations, and the Finance Committee Chair as part of the annual audit process.

During their employee orientation process, all employees will review and sign an acknowledgment that they have read and understand the code of ethics policy. An original signed copy will be kept in each personnel file. All supervisors and executives are required to sign the policy and reporting procedures annually.

Executive Committee. In this review, the Human Resources Director provides the CEO and the Executive Committee with a history of his compensation and the annual salaries of about 10 other nonprofit executives as examples (some are higher and some are lower than his salary). The annual salary is based on years of experience as an executive director, the size and kind of agency that Washburn is, the compensation that we need to provide to key staff that are generally licensed and often PhD's, and the performance of the individual in the position. More general nonprofit salary surveys are so broad that they do not adequately reflect the influence of some of these issues. More specific salary surveys, such as the one done by the Minnesota Association of Community Mental Health Providers, are mostly out state community mental health centers which reflect much lower salaries than executive directors in metropolitan organizations. Many of these have little or no fund raising component to them, and many of them are largely public sector funding.

The CEO's incentive pay is framed by a board policy on executive compensation that indicates the board preference to have some of the CEO's compensation tied to annual incentives. The annual objectives to be incentivized and the amount of incentive tied to each objective are determined through conversation between the Executive Committee and CEO as a part of the annual performance review. The CEO reports on his achievements or failures to achieve the previous year's objectives and indicates the level of incentive pay that he thinks he has achieved for each objective. The Executive Committee either agrees with his assessment or provides an alternative assessment and level of incentive pay. The objectives and the level of incentive for the coming year are proposed by the CEO as part of his review and then considered and modified if necessary
